**RAFFLE RULES AND REGULATIONS**

1. This raffle is conducted by La Cocina, Inc., located at 2948 Folsom St., San Francisco, California 94110. La Cocina is a non-profit organization under Internal Revenue Code Section 501(c)(3) and as defined by California Revenue and Taxation Code Section 33-0039466. All proceeds, less expenses, will benefit the La Cocina, Inc., operational needs.
2. The raffle will be conducted at the Tacolado event at the Spark Social (601 Mission Bay Boulevard North, San Francisco) from 11am PT on September 24, 2023, with tickets available for purchase while quantities last until 5pm PT on September 24, 2023.
3. A maximum of 5,000 tickets will be sold at \$5.00 per ticket. Multiple tickets can be purchased at discounted prices: 10 tickets = \$40 (\$4/ticket), 20 tickets = \$60 (\$3/ticket), 50 tickets = \$100 (\$2/ticket). The odds of winning are dependent on the number of valid entries up to 5,000.
4. Purchasers of tickets must legibly write their name, phone number, and email address on the ticket.
5. If more than one name is listed on the ticket, the first name listed shall be considered the "entrant." La Cocina, Inc. shall, will and can have no obligation for delivery of any prize to any person other than the entrant. La Cocina will contact winners to coordinate shipping by prize sponsors.
6. People under age 21 may not purchase or have their names identified as entrants. Raffle is only open to U.S. residents.
7. Participants need not be present to win.

## **TICKETS**

Each ticket cost \$5.00. Multiple tickets can be purchased at discounted prices: 10 tickets = \$40 (\$4/ticket), 20 tickets = \$60 (\$3/ticket), 50 tickets = \$100. Each ticket purchase benefits La Cocina's entrepreneurs and program. You need not make a purchase outside the cost of a ticket. Only one method of payment, one name, one phone number and one email address are permitted per ticket. Only one eligible person may be entered in the raffle per ticket sold. If the name of more than one person is submitted with a ticket purchase, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of prize by a group purchasing a ticket in common shall be to the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as a winner.
